### SPECIFIC ENTRY AND TRIAL INFORMATION - PLEASE READ!

**QUESTIONS ON ENTRIES:** The first attempt at resolving an issue on an entry form will be made by email. If no response is received from the competitor within a reasonable amount of time, the Trial Secretary may telephone. Please include a LEGIBLE phone number and a LEGIBLE e-mail address on your entry form.

**WAITING LIST:** In the situation that entry limits are filled, a waiting list of additional entries will be kept by the Trial Secretary.

**PRETRIAL MOVE-UP DEADLINE:** See cover page. Move-ups must be received in writing by email. The notice of the move-up must identify dog, handler, dog's CPE number, current classes and levels entered, and what classes need to be moved up one level.

**MOVE-UPS FROM SATURDAY TO SUNDAY**: Move-ups will be accommodated in those classes repeated at the trial. Written requests for Sunday move ups must be submitted to the Trial Secretary no later than 30 minutes after the end of the last class of the day.

WALKTHROUGHS / BRIEFINGS: If you have volunteered (thank you!) and it is more convenient for you to walk with a different group (other than your group) in the 345C and 45C classes, please feel free to do so! Otherwise, please respect your fellow competitors by walking with your appropriate group. Be alert for announcements that there may be one walk-through for any given class. All the level 1, 2, 3 and the classes where 1&2 are combined will have one walk-through.

**REFUNDS**: Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee. There shall be no refunds for entries withdrawn after the closing date. However, a 50% refund of entry fees for injuries to dogs or handlers, or bitches in season, <u>may</u> be given if the request is received in writing by the Trial Secretary ON OR BEFORE the move up deadline or when entry limits are reached, whichever occurs first. All refund requests MUST be in writing and MUST be accompanied by a <u>dated letter</u> from your Veterinarian (or Doctor, if the injury is to the handler) <u>on your</u> Veterinarian's (or Doctor's) letterhead with a brief statement <u>explaining the reason the</u> <u>dog, or the handler, cannot compete</u>. Also, no entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

**<u>CHECKS WRITTEN ON FOREIGN BANKS</u>**: Include an additional \$20 fee with your entry fees if your check is not payable through a United States bank (note: Canadian postal money orders are NOT payable through a U.S. bank).

**<u>BAD CHECKS</u>**: Bad Checks are defined as any check that does not clear our bank the FIRST time it is deposited, in addition to not clearing our bank any successive times it is

**deposited.** Any person who writes a "bad check" for ANY reason will not be allowed to participate in this trial or any future CATS trial until such time that CATS is reimbursed in cash, for the full amount of said "bad" check plus any and all amounts charged to CATS by CATS' bank (owed to CATS) and a \$30 returned check charge (owed to the trial secretary). VENDORS: There are no vendors at AK9C.

**<u>SHOW SITE FACILITIES</u>**: This is a busy dog day care, boarding and training facility. Please keep your dogs away from other dogs. They are probably not as well trained as your dogs!

**LEASH RULE:** The site owners require that <u>ALL DOGS be on a leash</u> except when using the warm-up jump or while in the ring. There are no exceptions to this requirement. No flexi-leads are allowed at AK9C.

**WARM UP AREAS:** There will be a warm-up jump available for ENTERED DOGS. Please instruct your children to not play on the obstacles. No other obstacles may be set up at the show site for the purpose of training or warm-up.

**WORKER RAFFLE**: CATS is offering a CASH Worker Raffle, along with items from vendors. Make sure you check in with the Ring Managers and receive your tickets. Names will be drawn toward the end of each afternoon so listen for the announcements.

<u>CLEAN UP</u>: Cleaning up after yourself and your dog(s) at the show site and at the motels is a **must**. The Event Committee may dismiss competitors that fail to clean up after their dogs. **Per AK9C rules**, a **\$20 fee will be assessed to any handler whose dog eliminates in the ring**.

**FOOD:** Due to COVID, no food will be provided at this trial. Please plan accordingly. There are several local restaurants nearby.

**DISCIPLINARY ISSUES:** It is expressly understood that competitors alone are responsible for the behavior of their dogs, family and guests. Any competitor whose dog(s), family or guests create unnecessary disturbances or engage in unsafe or disruptive behavior may, at the discretion of the Organizing Committee, be asked to leave the show site. Entry fees will not be refunded. The CATS CPE Trial Committee will review disciplinary problems in accordance with CPE Rules and Regulations. ### General CPE rules for entries/show site:

Dogs must be at least 15 months or older the first day of the trial Blind (both eyes), lame, in season or aggressive dogs may not enter the show. The Club may choose to exclude any of the above from the site. Dogs must be registered with CPE prior to the closing date of the trial, or by the trial date for Day Of Show entries.

Dogs must be able to be measured at their first show. If a dog cannot be measured, the dog cannot run and no refund will be issued. Dogs within ½" of a jump height require at least one more measurement. When dogs reach their second birthday, a measurement is required. All dogs must be measured at their first trial regardless of jump height.

Only CPE Judges can measure dogs.

Electronic shock collars are not allowed at ANY CPE trial – training or bark. Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. A warm-up jump shall be provided for all entered dogs. No relieving of dogs in the warm-up area.

### Dogs in the ring, leashes, exiting the ring

Dogs shall run without anything attached to its body except, optionally, a single, flat collar with no tags/anything attached. This is for the safety of the dog. The only other exception is a small barrette or rubber band to keep hair out of a dog's eyes.

Leashes may not have anything (other than name/license tags) attached to them when used in the ring.

Dogs may enter the ring on a collar, quick release harness or head halti/leader. If prong collars are allowed per the show site, they may *not* be used to take a dog into the ring.

All handlers have the choice to put their leash in their pocket or safely loop it around their waist or neck, it does not have to be out of the dog's sight,

however, if the dog interacts with it during the run, it would be considered a toy and result in an NT.

Dogs must be under the handler's control when leaving the ring or the judge may enter the run as No Time - NT.

### **Declared Training In the Ring**

We (CATS) will offer Declared training in the ring. The handler has the option if they want to use a toy or training aid at any time during their run, the handler must approach the Judge during Walkthrough or previously in that trial day for the Judge to approve the toy or training aid for use on the course.

Handler must alert the Judge upon entry to the ring that the dog will be TIR. Handler is then allowed to have a reasonably sized silent toy/aid with them for use once their run has started (this toy must be approved by the Judge of record PRIOR to the start of the class to determine its eligibility, absolutely no food/scents/audible devices). The toy is NOT allowed to be used in either gate chute or prior to the previous dog leaving the ring.

See the online rulebook or current member letter for additional rules. The following items *are* considered training in the ring (see Fix and Go):

Violating the 4 paw safety rule (directing the dog back onto the contact) Start line stay – leaving the dog and going back again to reposition the dog after the handler passes the plane of the first obstacle (before the handler leaves the dog, repositioning or repeated commands can be a delay of start)

Putting the dog back on the table in the point games

### While running on course

The handler will direct the dog through the course without a lead. Food, toys, training devices (includes fanny packs and leash attachments) are not allowed within 10' feet of the ring. Clickers, training whistles and squeaky toys are not to be used within distraction distance of the ring.

The handler may not carry anything that could aid the dog in its performance. Exclusion: Handicapped/Differently Abled Handlers using a cane, scooter, wheelchair. etc.. to enable their progression around the course.

The handler may use any verbal or visual commands to direct the dog through the course. The Judge may assess a 5 fault penalty to elimination for any command that is not given in a sportsmanlike manner. Faults can be but are not limited to: foul or abusive language, display of anger, extreme frustration or excessive harshness. If the fault is severe enough, the Judge has the right to excuse the exhibitor from the ring and / or the remainder of the trial. If excused from the trial, a report would be filed with CPE. See Faults, Eliminations and Excusals in the rulebook.
